ION* Affiliate Program Summary

Welcome to the ION* Affiliate Program! Thank you for your passion for ION* and your enthusiasm in sharing the benefits of our products and your personal experience with your world. Here is a summary of our program details.

Commission rates:

There are two types of purchases: subscription and one-time purchases. For subscription purchases, Affiliates will receive a fixed commission of 10% for every subscription order that comes through their affiliate link. Customers have the option of choosing 30, 60, or 90 days for their subscription's recurring delivery. The affiliate will be attributed commission on each customer's subscription order so long as the order is placed for that customer within 100 days of their last subscription order. For one-time purchases (non-subscription purchases), we offer a tiered rate based on the sales for that month (shown below). Sales are net of discounts, taxes, shipping, returns and refunds. Merchandise purchases are not eligible for commissions.

In addition to the above-mentioned commission, as of 5/15/2023, for every new subscription order placed using an affiliate's link, the affiliate will earn a one-time \$5 bonus payment for the first order of that subscription only.

When & How paid:

For orders to be eligible for commissions, Affiliates must have completed the registration process on our partner affiliate platform. Affiliates will be paid monthly for their sales from the previous month. Payments will be made via online payment transfer by the 30th of the month. In order for a payment to be generated, Affiliates must earn \$100 from commissions and bonus payments in a month. If the commissions and bonus payments total less than \$100 in a month, commissions and bonus payments will be accrued until they meet or exceed \$100 and then will be paid out in the next payment cycle.

Using the example above, the Affiliate would be paid on the 30th of month 3 as he/she will not exceed the \$100 threshold until after the 2nd month of sales.

To ensure the timely delivery of your commissions and bonus payments, please ensure your account information is up to date. Failure of notification could result in a stop payment fee.

Cookies:

Cookies MUST be enabled for this program to work.

Affiliate link cookies are valid for 60 days. Sales will be credited to you if your affiliate cookie is the *last* one captured within this period and is still retained by the user's browser.

NOTE: Orders may not be credited to you if a user or the browser they are using blocks these cookies or the user has entered our website directly in a new private (incognito) session.

ION* Subscription program

The most cost-effective way for customers to purchase ION* is through our subscription program which provides 15% off on-going, auto-ship orders. When customers sign up for the subscription program using an affiliate link, the customer gets the best price on the product. The subscription program supports daily microbiome health/glyphosate protection for the customer integrated into their lifestyle for long-term benefit AND a consistent revenue opportunity for the affiliate. A win-win!

Promotional codes:
